If needed, the County of Ventura will issue addenda to make changes, additions, or deletions to this Notice of Sale. It is the responsibility of bidders to check our website and to acknowledge and return all addenda on or before the bid deadline.

Sales Tax

Unless otherwise definitely specified, the prices quoted are net to the Seller and do not include California Sales Taxes. If property bought is not for resale, 7.25% California Sales Tax will be added to bid prices. Sales tax must be paid to Seller unless the Buyer provides a California Resale Certificate (Form No. CDTFA-230, Rev 8-17). If the Buyer is outside of California and arranges for shipment by common carrier, sales tax will not be charged.
