6.	Public Authority Update	<ul> <li>Approved Memorandum of Agreement was approved for IHSS Providers by Ventura County, the Human Services Agency and SEIU2015:</li> </ul>	
		<ul> <li>Increase in wages are <b>estimated</b> to occur as follows for a total of 3 pay increases over the life of the 3-year agreement:</li> </ul>	
		<ul> <li>March 1, 2025 – Hourly wage increases to \$19.55hour</li> </ul>	
		• July 1, 2025 – Hourly wage increases to \$20.15hour	
		• July 1, 2026 – Hourly wage increases to \$20.57hour	

		<ul> <li>Public Authority will allocate 10K per fiscal year to purchase essential protective gear (gloves, masks and sanitizer) for distribution by SEIU2015 to IHSS providers.</li> </ul>		
		<ul> <li>Public Authority will allocate 20K per fiscal year for training opportunities for IHSS providers.</li> </ul>		
		<ul> <li>Bargaining Sessions Pay: IHSS providers will be paid for time spent in scheduled bargaining sessions.</li> </ul>		
		<ul> <li>Public Authority will be sending out a survey to IHSS providers requesting input on training preferences.</li> </ul>		
		<ul> <li>California Governor's Proposed Budget for 2025-2026: Governor Gavin Newsom's proposed state budget for the fiscal year 2025-2026 includes no reductions to the IHSS/PA budget, ensuring continued funding levels for the program.</li> </ul>
